The following matters are the business to be transacted and considered by the Committee.

1. Investment Reports

The Committee will review Investment Report for the month of and quarter ended June 2010. The Committee will recommend forwarding the reports to the Board for receipt and filing.

2. <u>Tieton Hydropower Project Financing</u>

The Committee will receive an update from Public Financial Management (PFM) with respect to the 2010 Tieton Hydropower Project Bonds closing set for August 10th.

3. Windy Point/Windy Flats Wind Energy Project

The Committee will receive an update from PFM with respect to the Windy Point/Windy Flats Wind Energy Project financing.

4. <u>Linden Windy Energy Project</u>

The Committee will receive an update from PFM with respect to the Linden Windy Energy Project and the financing of such Project. The Committee will also review the Resolution approving the Bonds and a Resolution approving the Continuing Disclosure relating to the Bonds and recommend that the Board approve such Resolutions.

5. Standby Bond Purchase Agreement Relating to the STS 2000 Bonds

PFM will update the Committee on the status of completion of agreement with the replacement liquidity provider related to the Standby Bond Purchase Agreement for the STS 2000 Bonds.



6. STS 2001 Refunding Bonds Swap Agreement

The Committee will review a confirmation from UBS regarding the amendment and restatement of the original swap transaction dated February 20, 2002. The Committee will recommend that the Board approve such amendment and restatement.

7. Renewable Energy Project Financings

The Committee will receive an update from PFM with respect to near-term renewable energy project financings.

8. <u>Mead-Phoenix / Mead-Adelanto Projects</u>

The Committee will be updated from PFM regarding status of renewals for the Standby Bond Purchase Agreements with JP Morgan for the 2008 Bonds.

9. Market and VRDO Update

The Committee will receive a market and VRDO status report from PFM.

10. <u>Unsolicited Proposals</u>

The Committee will review unsolicited proposals that have been received from investment bankers. The Committee may take action with respect to such proposals.

11. Closed Session
