- Chiquita Canyon Landfill Gas Generation Project
 - Located at the Chiquita Canyon Landfill in Valencia, CA
 - 7.8 MW, 35,000 MWh in FY 22/23
 - Project Offline on January 31, 2024
 - Force Majeure Declared on February 22, 2024
- Original FY 24-25 Budget Total of \$984k
 - PPA Payments January 2025 through June 2025 only
- Revised FY 24-25 Budget Total of \$48k
 - PPA Payments None
- Resolution 2024-105
 - Project Vote: Burbank (16.6667%) and Pasadena (83.3333%)

2024 Federal Election Recap

What Does it Mean for SCPPA and Public Power?





- President-Elect Trump secured 312 electoral votes to Vice President Harris' 226
- Currently, he leads the popular vote 50.1%-48.3% (98% counted)
- Thousands of votes yet to be counted, mostly in the West
- Trump would be the second GOP presidential candidate to win popular vote since 1988 – the last one in 2004
- Vote turnout overall down from 2020: Trump projected to draw approximately three million less votes; Harris 11 million



- The GOP will maintain control of congress -- barely
- Current tally is 220-212, with three races yet to call (218 needed)
- GOP Rep. Duarte in 13th District (Central Valley) has slight lead, 50.6%-48.4%
- GOP Rep. Michelle Steele in 45th District (Orange County) is tied at 50% -- 35k left to count
- Final House tally expected to be a 1-3 seat margin for GOP- 219/221
- 119th Congress margin would be virtually same as 118th



- GOP gains control of US Senate, 53-47, with expected net gain of four seats
- GOP Flipped seats: Montana, Ohio, West Virginia, Pennsylvania (recount underway)
- Democrats retained seats in Arizona, Michigan, Wisconsin, and Nevada despite Trump victories in those states
- For first time in almost 70 Senate races, the presidential winner and senate race winner in a state were of different parties
- Election means new GOP Senate leader for first time in 18 years



- Last week, Senator John Thune (R-S.D.) was elected majority leader
- New GOP Senate Leadership team includes Sens. John Barrasso and Sen. James Lankford (R-Okla.), both from large wind power generating states
- Combined with South Dakota's high wind generation, it's among the most renewables states oriented leadership teams in recent memory
- Democrat leadership team to continue under Sen. Chuck Schumer (D-N.Y.)
- House GOP leadership team remains the same, led by Speaker Mike Johnson (R-La.)

What Does It Mean For Us?



- Too early to know fully
- A major tax bill will be advanced: ARBs, municipal financing etc.
- Full "claw back" of IRA renewable credits unlikely (Budget "Reconciliation")
- Energy Permit Reform Is likely: Transmission etc.
- FERC leadership changes
- The House margin will be extremely close
- The power to "control" Floor outcomes When/will the center prevail?





- Senators Padilla and Schiff will be important allies
- Sen. Padilla and staff have important GOP relationships
- Moderate GOP senators particularly Murkowski (R-Ark.) and Collins (R-Maine) will be key players
- Support for public power in the House and Senate GOP Conference? Possible
- Opportunities for bipartisanship?: Yes
- An important unknown: Trump cabinet and sub-cabinet political appointees
- Much policy and regulations formulated/implemented below Secretary level



Senator-Elect Sabrina Cervantes (Roth)

- Sitting Assemblymember
- Has served as an Assemblymember since 2016
- Similar political leanings as Roth

Senator-Elect Steven Choi (Min)

- Anaheim
- Sten Choi is a former Republican Assemblymember.
- Led efforts to improve education, cut taxes, address homelessness, and reduce the cost of healthcare. Steven is pro-business and opposes efforts that increase the cost of gas and energy.
- Conservative shift from Newman.





Senator-Elect Sasha Pérez (Portantino)

- In 2020, Pérez was elected to Alhambra City Council and immediately sworn-in as Mayor, making her the youngest female mayor in San Gabriel Valley history and the youngest Latina mayor to lead a city of more than 50,000 in California.
- Progressive shift from Portantino.

Senator-Elect Eloise Reyes (Vacant)

- Sitting Assemblymember
- Has served as an Assemblymember since 2016



Laura Richardson v. Michelle Chambers (Bradford)

- Laura Richardson is the more moderate D and served on Long Beach City Council, in the State Assembly, and in Congress.
- Michelle Chambers is the more progressive D (endorsed by Bradford) and served on Compton City Council.

Richardson - 50.5%

Chambers - 49.5%

Assemblymember-Elect Nick Schultz (Friedman)

- Mayor of the City of Burbank
- Currently serves as a Deputy Attorney General with the Special Prosecutions Section of the Attorney General's Office with the California Department of Justice
- Knowledge of energy/POU issues
- "I have pushed Burbank Water and Power (BWP) to develop a roadmap to get to 100% clean energy by 2030 by investing in an electric grid that affordably and aggressively reduces greenhouse gasses with renewable energy (e.g., solar and wind)."
- Similar political leanings as Friedman

Assemblymember-Elect Mark Gonzalez (Santiago)

- District Director of Asm. Miguel Santiago
- Former Chair of the LA County Democratic Party
- Endorsed by LA Times, Newsom, and Karen Bass
- Supports streamlining environmental regulations to build projects
- Similar political leanings as Santiago





Assemblymember-Elect John Harabedian (Holden)

- Worked as a prosecutor at the Los Angeles District Attorney's office. He was a Sierra Madre City Council member from 2012 to 2020, and served as Mayor. He ran unsuccessfully for L.A. County supervisor in 2020.
- Formerly an attorney at Latham & Watkins, Stanford's Immigrants' Rights Clinic, and the Equality Pro Bono Project.
- Likely to be more moderate than Holden.

Assemblymember-Elect Celeste Rodriguez (L. Rivas)

- Mayor of the City of San Fernando
- Previously served as the Los Angeles Mayor's Deputy Director of Community Development Strategies
- Similar political leanings as Rivas





Assemblymember-Elect Jose Solache (Rendon)

- President of the Greater Lakewood Chamber of Commerce
- Served as a Mayor, Mayor Pro-Tem, and Councilmember in the city of Lynwood since 2013.
- Served for three terms on the Lynwood Unified School District's Board of Education
- Likely to be more moderate than Rendon

Assemblymember-Elect Jessica Caloza (W. Carrillo)

- Served in the Obama Administration in the U.S. Department of Education.
- Appointed as a Commissioner on the Board of Public Works by Mayor Eric Garcetti in 2019.
- Served as Deputy Chief of Staff at the California Department of Justice under Attorney General Rob Bonta.
- Similar political leanings as W. Carrillo, although W. Carrillo has endorsed her opponent, Frankey Carrillo.





Assemblymember-Elect Robert Garcia (Reyes)

 Robert Garcia is a progressive D (endorsed by Reyes) and served as President of the Etiwanda School District Board of Trustees Assemblymember-Elect Sade Elhawary (Jones-Sawyer)

 Sade Elhawary is a progressive D (endorsed by Jones-Sawyer) and serves as a youth organizer at Community Coalition.





Senator-Elect Valladares (Ochoa-Bogh)

 Valladares served as an Assemblymember from 2020-2022 until she was defeated by Asm. Pilar Schiavo in a close race.

Clarissa Cervantes v. Leticia Castillo (S. Cervantes)



 Clarisa, a Democrat, is the sister of Senator Sabrina Cervantes and former Riverside City Council Member. Priority issues include making housing and healthcare affordable, promoting public safety, strong backer of labor unions.

 Leticia, a Republican, is a licensed Clinical Psychotherapist. Priority issues are mental health services, reducing crime, pro-school choice, reducing the cost of living, pro-2nd amendment rights.

- Gonzalez, a Republican, is a veteran, small business owner, and pastor.
- Priority issues include increasing access to healthcare, education, and addressing the cost of living.



Federal Gov Affairs Consultant Services

- SCPPA's Federal Government Affairs Consultant Services Contract
 - Board approved 3-year contract on January 20, 2022, with The Ferguson Group
 - Monthly retainer started at \$10k with annual \$500 adjustment
 - Contract authorizes a 3-year extension
 - However, not-to-exceed amount does not accommodate 3-year extension
 - Legislative Advocacy expenses are allocated equally to 12 Members in the A&G Cost Allocation Plan

Recommended Action

- Authorize contract's 3-year extension
- Continue \$500 annual monthly retainer adjustment
 - □ \$11.5k, \$12k & \$12.5k in 2025, 2026, and 2027, respectively
- Increase the not-to-exceed amount to accommodate 3-year extension
 - □ Current not-to-exceed is \$450k
 - □ Increase by another \$450k (total \$900k)



State Legislative Consulting Services

• SCPPA's State Legislative Consulting Services Contract

- Board approved 3-year contract on January 20, 2022, with Samson Advisors
- Monthly retainer is \$15k
- Contract authorizes a 3-year extension
- However, not-to-exceed amount does not accommodate 3-year extension
- Legislative Advocacy expenses are allocated equally to 12 Members in the A&G Cost Allocation Plan.
- Recommended Action
 - Authorize contract's 3-year extension
 - Increase the not-to-exceed amount to accommodate 3-year extension
 - □ Current not-to-exceed is \$600k
 - □ Increase by another \$600k (total \$1.2m)
