Updates to Appendix A

Volume I – Management Proposal	
Chapter 1	Seller's Qualification and Experience (page limit 3): Provide a description of similar or related projects performed by your firm in the past 5 years.
Chapter 2	Organizational Approach to Work (page limit 3): 1. The Seller should include the organizational approach for its team, including the roles of and management of subcontractors, and an organizational chart that identifies overall reporting structures. 2. Provide information that is detailed enough to demonstrate that the Seller has the project management skills to deliver the required project on time and within budget. 3. Approach shall detail what reporting (including frequency) will be made available to LADWP and how LADWP will be afforded visibility into Contractor performance. Transition and disengagement procedures should be addressed for work that will be handed off to LADWP.
Chapter 3	Risk Management Approach (page limit 2): Provide a list of potential risk for the project and the approach to mitigate them. Include process for escalating issues within the Seller's organization and LADWP should be identified.
Chapter 4	Qualifications of Key Personnel (1 pages each): Provide roles of each key personnel as well as a summary of qualifications and experience of key personnel who will work on the contract, including subcontractors. Key Personnel References: Seller must provide a minimum of three relevant references for each team member identified as key personnel. References should be on similar projects or services that closely match the size, complexity, and tasks described in this RFP. LADWP may contact these references to gather information about their experiences and satisfaction with the ability of the key personnel identified.
Volume II – Technical Proposal	
Chapter 1	Technical Approach (page limit 15): Provide sufficient information to demonstrate the Seller's understanding of the requirements. Must comprehensively describe the approach to meet all the requirements in the RFP. Particular emphasis should be given to confirm depth and breadth of technical and/or industry knowledge. Any efforts required from LADWP should also be addressed herein.

Chapter 1	Appendix A – The Seller shall provide this completed Appendix A as stated in the Note above.

All other terms and conditions of the RFP remain unchanged.
